DIRECTIONS:

Use caution when spraying on synthetic surfaces which may be damaged by solvents, such as rubber and asphalt tile, some paints and certain plastics. Test the durability of the surface by spraying as inconspicuous area. Spray on the surface to be cleaned, allow it to act a few seconds, then wipe off with a clean cloth. For difficult to remove marks, repeat the application, allowing **WIPE OFF** to act on the surface for a longer time. For porous surfaces scrub the area with a stiff bristle brush after spraying, then wipe off with pressure wash.
