DIRECTIONS

Test in an inconspicuous area before use. (When diluting, always add this product to water, NOT water to product.) Avoid splashing of product.

For general cleaning dilute at a ratio of 10 part water to one part **ZX-WALL & EQUIPMENT CLEANER**.

For heavier soiled areas dilute at a ratio of 5 parts water to 1 part **ZX-WALL & EQUIPMENT CLEANER**.

Make sure to apply from the bottom up. The solution may be either brushed on or sprayed on and allow dwell time until foam blanket occurs. Make sure to always rinse with water and re-apply if necessary. **WARNING: Do not use with hot water.**
